Return of Turf

Preparation of returns

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

Declaration

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

Lodgement Date

Quarterly Returns

The return together with payment is due within 28 days after the end of each quarter. For example the return and payment for the quarter ending 31st December (i.e., for the months of October, November and December) is due on or before 28th January.

Annual Returns

The return together with payment is due within 1 month and 28 days after the end of the levy year. The return and payment for the 2006/2007 levy year is due on or before 28th August 2007.

***Note:** A levy year for Turf is the same as a financial year (i.e. 1 July 2006 to 30 June 2007)

A person may apply for exemption from the requirement to lodge quarterly returns for a levy year* if the person has reasonable grounds for believing that the total amount of charge and levy that the person is, or is likely to be, liable to pay in the levy year* is likely to be less than \$750. An application to pay the levy and export charge annually must be made in writing to the Secretary of the Department of Agriculture, Fisheries and Forestry.

Penalties

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
