**Preparation of returns**

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

**Declaration**

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

**Lodgement Date**

**Quarterly Return:**

The return together with any payment is due within 28 days after the end of each quarter.

For example the return and payment for the quarter ending 30<sup>th</sup> June (ie, for the months of April, May and June) is due on or before the 28<sup>th</sup> of July.

**Annual Return:**

The return together with any payment is due on or before 28<sup>th</sup> August.

For example the return and payment for the 2004/2005 levy year is due on or before 28th August 2005.

Note: A levy year\* for forest & wood products is the same as a financial year (ie, 1<sup>st</sup> July to 30<sup>th</sup> June)

A mill operator, exporter or importer may apply through LRS for an exemption from the requirement to lodge quarterly returns for a levy (financial) year\* if that person has reasonable grounds for believing that the total amount of levy/export charge payable by the person for that year will be less than \$1,000. If exemption is granted, returns must be lodged on an annual basis. Please contact your nearest LRS office if you require an application for exemption form to be sent out to you, or if you need further clarification in relation to annual returns.

**Penalties**

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
