**Preparation of returns**

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

**Declaration**

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

**Lodgement Date**

The Annual return together with payment is due on or before 28<sup>th</sup> August.

For example the return and payment for the 2003/2004 levy year of wool is due on or before 28<sup>th</sup> August 2004.

Note: A levy year for Wool is the same as a financial year (ie, 1<sup>st</sup> July to 30<sup>th</sup> June)

A person (other than a person who exports wool) may apply for exemption from the obligation to lodge monthly returns for a levy (financial) year if there are reasonable grounds for believing that the total amount of levy - for which the person will be liable in that levy year will be less than \$500. If exemption is granted, returns must be lodged on an annual basis.

**Penalties**

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
