Annual Return of Cherries

****IMPORTANT - Cherry Return – Available online from 31 March 2012 ****

The levy return form for Cherries will be available for lodgement through Levies Online from 31 March 2012. DAFF Levies' preferred method of lodging returns is online as it enables real time accurate processing of returns and access to online return history. All relevant information, including registration, can be located at www.leviesonline.daff.gov.au/LRSONLINE. For inquiries or assistance relating to the lodgement of your return through the Levies Online System, please call your state office. If you have a technical inquiry, please call the Levies Online Helpdesk on 1800 022 384.

Preparation of returns

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

Declaration

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

Lodgement Date

The return with payment is due on or before 28th April in the next levy year. For example, the return and payment for the 2012-2013 levy year (1st April 2012 to 31st March 2013) must be lodged by 28th April 2013.

Note: A levy year for cherries is 1st April to 31st March the following year. However, for the 2011-12 cherry season, a levy year is 1st February 2011 to 31st March 2012.

Penalties

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
