Purpose

To notify all livestock exporters of the reduction of a range of fees in the current fee structure for AQIS Live Animal Exports (LAE) Program that will be implemented on 1 October 2007.

Issue

The reduction of a range of fees for the LAE Program will be implemented on 1 October 2007. In general terms, there has been approximately 7% reduction on a range of fees applicable to the export of livestock.

The details of the fees are as follows:

Livestock by Sea

- A per head fee separated into tiers and species by the level of complexity of the importing country protocol (Table 1).
- The per head rate includes overtime but not travel or outports costs.

The list of countries in each tier has not changed.

A time based fee of \$192 per hour charged at quarter hour units applies to the following:

- . For export of sheep, goats, cattle and buffalo to countries which are not listed in a tier
- . For exports of camelids and deer

The outport fee, travel fee, AQIS on-board authorised officer, export licence application fee and export licence assessment fee have not changed.

Livestock by Air

- A time based fee of \$192 (reduced from \$208) per hour, charged at quarter hour units of \$48 (reduced from \$52).
- During the transition phase there may be AQIS invoices for one consignment with some time based charges at \$52 per ¼ hour (for services delivered before 1 October) and some time based charges at \$48 per hour per ¼ hour (for services delivered on or after 1 October).
- AQIS plans to complete a full fee review in 2008.
