1 Purpose

The purpose of the notice is to provide the current list of Islamic Organisations approved to issue Halal certification for red meat under the Export Control (Meat and Meat Products) Orders 2005 (ECMMPOs).

2 Background

AQIS Meat Notice 2006/19 provided details of recognised Islamic Organisations approved to provide Halal services and certification to the Australian meat industry. This list has been updated to include an additional Islamic Organisation approved to supply certification in accordance with the ECMMPOs.

It is important to note that some countries (eg Malaysia, Indonesia, Saudi Arabia, UAE and Singapore) conduct their own assessment and approve Islamic Organisations and therefore have their own individual lists. Islamic Organisations that wish to be able to issue Halal certification for any of these countries must first approach the respective Islamic authorities of that country for approval.

AQIS Meat Notice 2008 / 02 – Recognised Islamic Bodies

Islamic organisations approved to supply Halal certification in accordance with the ECMMPO's are eligible to certify Halal meat for all countries that do not individually approve and list Islamic organisations.

Specific listing for those countries that individually approve and list Islamic organisations is noted for each organisation in Attachment 1.

3 Responsibilities

3.1 Establishment Management

Establishment management should check with their Islamic Organisation/s to ensure they are approved to certify product for the various countries.

3.2 AQIS OPS

- Ensure, where required, that the Islamic Organization/s are listed for the country/countries the establishment is proposing to export Halal products.
- Verify, where applicable, that appropriate Halal programs are approved and complied with at the establishment (for example, Saudi Arabia, Malaysian, etc.).

3.3 AQIS ATM

As appropriate, approve and verify the establishment's Halal program.
