Annual Return of Honey Purchased/Sold/Used/Exported

Preparation of returns

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

Declaration

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

Lodgement Date

The Annual return together with any payment is due on or before 28th February.
For example the return and payment for the 2011 levy year is due on or before 28th February 2012.

Note: A levy year is the same as a Calendar year (ie, 1st Jan 2011 to 31st December 2011)

Annual Returns

A producer of leviable honey must lodge a return for a levy year if, in that levy year:

- (a) the producer:
- (i) sells honey by designated sale**; or
 - (ii) uses honey in the production of other goods; and
- (b) the total weight of the honey so sold or used is more than 600 kilograms.

**designated sale means a sale of honey by a producer, except:

- (a) to a first purchaser; or
- (b) to a buying agent; or
- (c) by a selling agent

A person who has received an exemption from the requirement to lodge quarterly returns for a levy year must lodge an annual return for that year.

Please contact your nearest DAFF-Levies office to ascertain if you qualify as an annual payer.

Penalties

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
