**Return of

Preparation of returns

Where the return is being completed by hand please use BLOCK LETTERS and do not use pencil.

When the address section at the top of the return is being completed a street address must be given in the business address section. If your postal address is a PO Box or Bag please insert these details in the postal address section. If both addresses are the same write the words 'as above' in the postal address section.

Declaration

The declaration on the return form must be completed and signed by:

- In the case of an individual – that person;
- In the case of a body corporate – a company director, company secretary, or a principal officer in the body corporate;
- In the case of a partnership – one of the partners.

Lodgement Date

Monthly:

The return together with payment is due within 28 days after the end of the month in which the export took place. For example the return and payment for the month of October is due on or before 28th of November.

Annual:

The annual return with payment is due on or before 28th August in the next levy year. For example, the return and payment for 2003/2004 levy year must be lodged by 28th August 2004.

A person may apply through LRS for exemption from the requirement to lodge monthly returns for a levy year if the person has reasonable grounds for believing that the total amount of charge that the person is, or is likely to be, liable to pay in the levy year is likely to be less than \$750. Where exemption is granted, returns must be lodged annually to LRS.

Penalties

Where levy/export charge is paid late, penalty will be payable at the rate of 2% per month compounding on the sum of the unpaid amounts, including penalties already accrued.
