SECTION 1. EXPORTER DETAILS	<p>The Notice of Intention (NOI) must provide AQIS with details of the person exporting their animal/reproductive material.</p> <p>We also ask that you provide details of the person AQIS are able to contact regarding your export.</p>																								
SECTION 2. IMPORTER DETAILS	<p>The importer details are required on the Health Certificate and Export Permit, so it is important for these details to be completed correctly.</p>
